

PRIVACY POLICY

OUR COMMITMENT TO YOUR PRIVACY

This policy is intended to help the user understand how BNBVestor, its subsidiaries and affiliates "BNBVestor," "we," or "us" collect, use and safeguard the information provided on our mobile app.

BNBVestor is aware of our members concerns about their privacy. Here is where we tell you what we at BNBVestor will and won't do with your personal information on the site; and where we inform the rules we expect our members to adhere to.

PRIVACY POLICY

We don't ask you for personal information unless we need it, or unless it will help with your BNBVestor experience.

We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.

Below is our privacy policy which incorporates these goals:

It is BNBVestor's policy to respect your privacy regarding any information we may collect while operating our mobile apps.

INFORMATION THE APPLICATION OBTAINS AND HOW IS IT USED

User Provided Information

Our application obtains the information the user provides when he or she downloads and register the Application. Registration with us is optional. However, please, keep in mind that users may not be able to use some of the features offered by the Application unless they register with us.

When users register with us and use the Application, generally provide (a) name, email address, user name, password and other registration information; (b) transaction-related information, such as when users make purchases, respond to any offers, download or use applications from us; (c) information provided to us when contacted for help; (d) credit card information for purchase and use of the Application, and; (e) information entered by the user into our system when using the Application, such as contact information and project management information.

We may also use the information provided by the user to contact them from time to time to provide any important information, required notices and marketing promotions.

User Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device they use, the mobile devices unique device ID, the IP address of the mobile device, the mobile operating system, the type of mobile Internet browsers used, and information about how the Application is managed.

The Application collects precise real time location information of the device

When the user visits the mobile application, GPS technology (or other similar technology) may be used to determine a current location to find a city and display a location map with relevant advertisements. We will not share the user's current location with other users or partners.

If the user does not want us to use their location for the purposes set forth above, then the location service for the mobile application located in your account settings or in your mobile phone settings and/or within the mobile application must be turned off.

Mobile app Visitors

Like most mobile app operators, BNBVestor collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. BNBVestor's purpose in collecting non-personally identifying information is to better understand how BNBVestor's visitors use its mobile app. From time to time, BNBVestor may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its mobile app. BNBVestor also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on BNBVestor.com blogs. BNBVestor only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses are visible and disclosed to the administrators of the area of the site where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to the BNBVestor's mobile app choose to interact with BNBVestor in ways that require

BNBVestor to gather personally-identifying information. The amount and type of information that BNBVestor gathers depends on the nature of the interaction. For example, we ask visitors who sign up for an account at BNBVestor.com to provide a username and email address, as well as their real names and other identifying information. Those who engage in transactions with BNBVestor by purchasing access to the BNBVestor products, are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, BNBVestor collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with BNBVestor. BNBVestor does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain mobile app-related activities.

Aggregated Statistics

BNBVestor may collect statistics about the behavior of visitors to its mobile apps. For instance, BNBVestor may monitor the most popular blogs on the BNBVestor.com site or track member site activities via various leaderboards. BNBVestor may display this information publicly or provide it to others. However, BNBVestor does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

BNBVestor discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (a) need to know that information in order to process it on BNBVestor's behalf or to provide services available at BNBVestor's mobile apps, and (b) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using BNBVestor's mobile apps, you consent to the transfer of such information to them. BNBVestor will not rent or sell potentially personally-identifying and personally-identifying information to anyone. We disclose personal information when we believe it is appropriate to comply with the law (e.g., a lawful subpoena, warrant or court order); to enforce or apply this privacy statement or our other policies or agreements; to initiate, render, bill, and collect for amounts owed to us; to protect our or our users' rights, property or safety; or to protect our users from fraudulent, abusive, or unlawful use of, our Sites; or if we reasonably believe that an emergency involving immediate danger of death or serious physical injury to any person requires

disclosure of communications or justifies disclosure of records without delay. If you are a registered user of a BNBVestor mobile app and have supplied your email address, BNBVestor may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with BNBVestor and our products. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. BNBVestor takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Word of warning: If you post private information to any public forum, blog, public profile, or other public area of the site, all that information can be gotten by the public. You agree that BNBVestor shall not be responsible for the public's sharing of this information once you make it public via these or other methods.

Security

We use reasonable security measures to store and maintain personally identifying information to protect it from loss, misuse, alternation or destruction by any unauthorized party while it is under our control.

Cookies and Web Beacons

We may use cookies to identify users and customize their experience on our site based on information they give us. Cookies are small pieces of information or files that are stored on a user's computer by the Web server through a user's browser for record keeping purposes. A cookie itself is not designed or intended to read any information from your computer (other than the contents of the cookie); rather, it is an identifier used by the Web site that originally placed it on your hard drive. The actual contents of the cookie information can be retrieved by the same site's Web server in order to personalize, monitor, or regulate the use of the site. BNBVestor visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using BNBVestor's mobile apps, with the drawback that certain features of BNBVestor's mobile apps may not function properly without the aid of cookies. We do not use Web beacons or similar technology on our Sites. However, we permit third parties to place Web beacons on our Sites to monitor the effectiveness of advertising and for other lawful purposes. A Web beacon, also known as a "Web bug," is a small, graphic image on a Web page, Web-based document or in an e-mail message that is designed to allow the site owner or a third party to monitor who is visiting a site. Web beacons collect non-personally identifying information such as the IP address of the computer that the Web beacon is sent to, the URL of the page the Web beacon comes from and the time it was viewed. We do not use (or permit third parties to use) Web beacons to collect personally identifying information about you.

Business Transfers

If BNBVestor, or substantially all of its assets were acquired, or in the unlikely event that BNBVestor goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of BNBVestor may continue to use your personal information as set forth in this policy.

Co-Branded Services

Some services may be co-branded and offered in conjunction with another company. If you register for or use such services, both BNBVestor.com and the other company may receive information collected in conjunction with the co-branded services.

Advertisings

We may use third-party advertising companies to serve ads when you visit our mobile app. These companies may use information (not including your name, address, email address, or telephone number) about your visits to this and other mobile apps in order to provide advertisements about goods and services of interest to you. This Privacy Policy covers the use of cookies by BNBVestor and does not cover the use of cookies by any advertisers.

Links

Please be aware that we may provide links to third party Web sites from our Sites as a service to our users and we are not responsible for the content or information collection practices of those sites. We have no ability to control the privacy and data collection practices of such sites and the privacy policies of such sites may differ from that of BNBVestor.com. Therefore, we encourage you to review and understand the privacy policies of such sites before providing them with any information.
